## What is Home Title Fraud?

# How Do We Keep Your Home Safe?



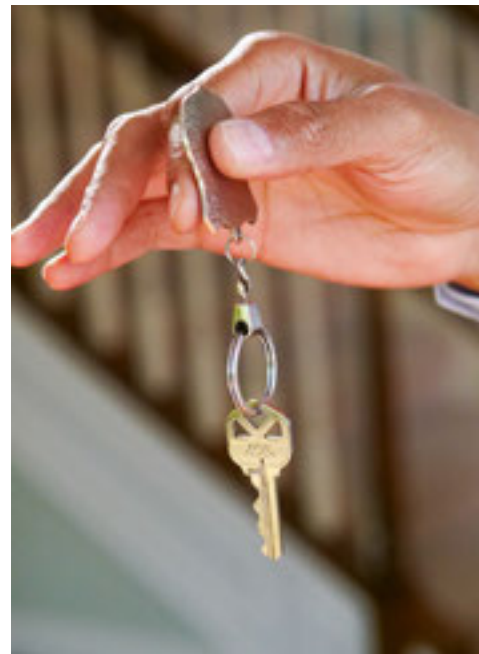
## New Property Record

We scan county records nationwide and generate an alert when a new property is detected matching personal information.



## Change in Owner

We generate an alert when there is a change in ownership on one of your identified properties.



## New Claim on Title

We will alert you when a new claim is made to one of your identified properties.



## Changing in Financing Terms

We will alert you when a lender files an update to their financing agreement that matches your personal information.



# Identity & Home Title Theft Victim Recovery Service

- 1** Call the 24/7/365 Identity Response Center  
If you have reason to believe you are a victim of Identity Theft or home title theft you should call the Identity Response Center at the toll-free number provided on your Certificate of Benefits.
- 2** Meet Your Dedicated Certified Recovery Specialist  
Once you have contacted the Identity Response Center your case will be assigned to an ICFE Certified Identity Theft Risk Specialist who will review the details of your case with you and determine the next steps in restoring your identity or home title. This process is known as the Identity Theft Intake Interview.
- 3** Return the Completed Recovery Packet  
After the Intake Interview process, you will receive an identity theft victim recovery packet containing the limited power of attorney and affidavit that you must sign and return authorizing your recovery specialist to start acting on your behalf.
- 4** Relax While We Restore Your Identity or Home Title  
Once authorized, we will investigate and take the necessary steps to restore your identity & home to pre-theft status.
